APPLYING FOR MEMBERSHIP

There are several types of membership, each running from 1st January to 31st December. Those joining during the year will receive back copies of the Journal for that year.

- * Any UK/Worldwide member taking the Journal by pdf: £ 8.00 p.a.
- * UK Individual Membership, with one copy per issue of the printed Journal: £10.00 p.a.
- * Family Membership per each additional related member at the same address joining at the same time (no Journal) **: £ 1.00 p a
- * Overseas supplement worldwide printed Journal – Surface Mail = £6: Total £14.00 p a
- * Overseas supplement USA/Canada printed Journal Membership – Airmail = £10: Total £18.00 p a
- * Overseas supplement Australia/New Zealand printed Journal – Airmail = £12: Total £20.00 p a

There is a mandatory one-off **joining fee of £2.00** to cover to cover the cost of the Members' Pack. This should be included with the subscription for the first year of membership.

NOTES

1. Applicants for Membership after 1st November will be assumed to be joining for the succeeding year, (unless otherwise specified on membership application form) and will not therefore receive a Journal until the following March but will be welcome to attend the November and December meetings.
2. Cheques and Postal Orders should be made payable to "Bedfordshire Family History Society".
3. Payments of Overseas Subscriptions must be by STERLING cheque or money order. It is regretted that the disproportionate exchange rates for small amounts of other currencies make it impractical to accept payments in those currencies. Sterling cheques can be obtained as follows:

Australia and New Zealand

Most banks will provide sterling cheques. Some of the larger genealogical societies hold UK bank accounts and are willing to provide sterling cheques for their members.

Canada

United States of America

Website www.foreignmoney.com. The cost to a USA client should be sought when you call. Other businesses offer similar services
